WAGE ORDER NO. IVA-21

PROVIDING FOR A MINIMUM WAGE INCREASE IN REGION - IVA

WHEREAS, the Regional Tripartite Wages and Productivity Board - IVA is mandated under **Republic Act No. 6727**, otherwise known as the **Wage Rationalization Act**, to periodically assess the wage rates and conduct continuing studies in the determination of the minimum wage applicable in the region or industry;

WHEREAS, the current Wage Order No. IVA-20 took effect on September 24, 2023;

WHEREAS, pursuant to Section 3(A), Rule II of the Omnibus Rules on Minimum Wage Determination, as amended, in the absence of any petition for a minimum wage adjustment filed, and in response to the directive of the President to the Regional Boards to initiate a timely review of the minimum wage rates in their respective regions, the Board, in its July 26, 2024 regular board meeting, decided to commence its minimum wage review, **motu proprio**;

WHEREAS, on July 29, 2024, the Board caused the publication of the notice of public hearings in the Philippine Daily Inquirer;

WHEREAS, after due notice to all stakeholders, the Board conducted the following wage consultation and public hearings to assess and determine the propriety of issuing a new wage order;

WHEREAS, on August 06, 2024, the Board received a joint petition for minimum wage adjustment of Php750.00 filed by the Bukluran ng Manggagawang Pilipino (BMP), Metal Workers Alliance of the Philippines (MWAP) and National Federation of Labor Union-Kilusang Mayo Uno (NAFLU-KMU) et al, and said joint petition has been presented and discussed by the petitioners during the consultation and the two regional public hearings;

WHEREAS, in setting the new minimum wage rates for private sector workers in the region, the Board considered the said petition and positions of affected sectors, the results of the regional public consultation and two regional public hearings which call for wage simplification, the prevailing socio economic indicators and criteria for wage setting such as the amount to restore the purchasing power of the peso, poverty threshold, comparability of wages vis-a-vis benchmark regions, the dispersal of industries across the region and recent policies, among others;

NOW THEREFORE, by virtue of the power and authority vested under RA No. 6727, RTWPB- IVA hereby issues this Wage Order.

Section 1. Amount of Increase and Renaming of Area Nomenclature. Upon the effectivity of this Wage Order, the area nomenclatures shall be updated as specified below, and minimum wage workers in the private sector within the region shall receive the following daily minimum wage increase:

- A. The Growth Corridor Area composed of the Extended Metropolitan Area and the Component Cities and First-Class Municipalities shall then be collectively called "Component Cities and First-Class Municipalities", with the following minimum wage increases:
 - 1. For the Extended Metropolitan Area:
 - a. P40.00 for the non-agriculture sector; and
 - b. P21.00 for the agriculture sector.
 - 2. For the Component Cities:
 - a. P41.00 (first tranche) and P20.00 (second tranche) for the non-agriculture; and
 - b. P21.00 for the agriculture sector.
 - 3. For the First-Class Municipalities:
 - a. P41.00 for the non-agriculture sector;
 - b. P40.00 (first tranche) and P35.00 (second tranche) for the agriculture sector; and
 - c. For the Municipality of Rosario, Cavite, P41.00 (first tranche) and P20.00 (second tranche) for the non-agriculture sector, and P40.00 (first tranche) and P35.00 (second tranche) for the agriculture sector.
- B. The Emerging Growth Areas shall then be called Second- and Third-Class Municipalities, with the following minimum wage increases:
 - 1. P25.00 for the non-agriculture sector; and
 - 2. P40.00 for the agriculture sector.
- C. The Resource-Based Areas shall then be called Fourth-, Fifth- and Sixth-Class Municipalities, with the following minimum wage increases:
 - 1. P35.00 (first tranche) and P30.00 (second tranche) for the non-agriculture; and
 - 3. P40.00 for the agriculture sector.
- D. Retail and Service Establishments Regularly Employing Not More Than 10 workers across all areas shall have an increase of P40.00.

Section 3. Basis of Minimum Wage. The minimum wage rates prescribed under this Order shall be for the normal working hours which shall not exceed eight (8) hours of work a day.

Section 4. Coverage. The wage increase prescribed herein shall apply to all minimum wage earners in the private sector within the region, regardless of their position, designation or status and irrespective of the method by which their wages are paid.

Section 5. Exemption. The following establishments may apply for exemption from compliance with this Wage Order, as provided under *the Omnibus Rules on Minimum Wage Determination, as amended*:

- a) Retail/Service Establishments regularly employing not more than ten (10) workers; and
- b) Establishments adversely affected by natural calamities and/or human-induced disasters.

Section 6. Penal Provision. Any person, corporation, trust, firm, partnership, association or entity which refuses or fails to pay the prescribed minimum wage rates in this Wage Order shall be dealt with pursuant to the provisions of *Section 12 of RA No. 6727*, as amended by *RA No. 8188*.

Section 7. Effectivity. This Wage Order shall take effect after fifteen (15) days from its publication in a newspaper of general circulation.
